Africa is now the world's youngest continent, with young people being the majority in many of the region's countries. Whether they live in the cities and towns of the rapidly urbanizing continent, or in rural villages and settlements; whether they come from middle-class backgrounds or from vulnerable families that are living in poverty, one thing is certain: these young people are ambitious to work for a prosperous and sustainable Africa. However, unemployment is one of the main problems that young people face across the continent. On top of that, in the absence of adequate social safety nets, young people are compelled to take low-productivity and low-wage jobs for their very survival. Employment in the informal economy is the norm and young women tend to be more disadvantaged than young men in access to work.

In this context, the GLF Africa Job Fair 2022 is organized to provide an avenue for students and young professionals in the YIL network and beyond, to learn more about the organizations and companies in sectors and fields that support people and nature across Africa.

The GLF Africa Job Fair will be held on September 14 (16:00-18:00 CEST; 17:00-19:00 EAT), on the road to the 2022 GLF Africa Digital Conference (September 15). The Africa Regional Job Fair is organised by the Youth in Landscapes Initiative and the Global Landscapes Forum in collaboration with the International Forestry Students Association and local organisations in Africa.

01 Landscape approach

The landscape approach refers to the tools and concepts for allocating and managing land to achieve social, economic, and environmental objectives in areas where agriculture, mining, and other productive land uses compete with environmental and biodiversity goals.

Such an approach holds a potential to help achieve this balance in areas where use of land for agriculture, livestock, mining and other forms of production, competes with environmental and biodiversity goals.

03 Sustainable finance

It aims to shift financial flows towards sustainable land-use models that are sustainable, equitable, inclusive and profitable. Until recently, the financial sector has been slow to recognize the threat that unsustainable land-use poses for climate change, biodiversity, water use, rural poverty and (gender) inequality.

02 Biodiversity

<u>Biodiversity</u> is the variety of life on Earth and the natural patterns it forms. The biodiversity we see today is the result of 4.5 billion years of evolution and, increasingly, of human influence as well. It forms the web of life, of which we are an integral part and upon which we so fully depend.

04 Tenure rights

Land tenure is about the relationship between people and the land, and how local laws and customs define that relationship. Land tenure for all – men, women, indigenous peoples – is not just a question of human rights, but an issue that impacts biodiversity, food security, and migration.

Those who own or control the land they work on are more likely to invest in sustainable land management practices such as tree planting and soil conservation.

05 Climate justice

The impacts of climate change will not be borne equally or fairly, between rich and poor, women and men, and older and younger generations. Consequently, there has been a growing focus on climate justice, which looks at the climate crisis through a human rights lens and on the belief that by working together we can create a better future for present and future generations.

Tips for CV and cover letter writing

1. Create a personal statement: write one or two sentences that summarize your experience, skills, and achievement. Include who you are, your value to the organization, and your career objectives. This statement can be used in the beginning of your CV or in your introduction email when you send your application to the recruiter. See example:



I'm a dynamic marketing specialist with extensive experience in international development. I've worked with multiple non-profit organizations in the development of regional marketing strategies, improving market reach and coverage. I'm currently seeking a senior marketer position in a globally-competitive organization

- 2. Spot your niche: build a list of target companies and organizations you want to work with. Make use of job searchers and identify the sectors with the most green-job opportunities such as agriculture, forestry, fisheries, tourism, waste management, transport, energy, and construction. Identify the most common roles in which you would fit in and tailor your CV and cover letter to the role.
- 3. Use keywords: keywords help scanning and readability. Identify keywords from the job descriptions and make sure to insert them into the body text of your CV (including your personal statement) and cover letter. Don't spam your CV and cover letter by repeating keywords unnecessarily.

4. Speak with numbers and facts: It is important to include examples of your best work by providing numbers and facts to your achievements. See example:



I helped expand the company's online presence by revamping its social media channels to improve engagement by 65%

5. Confidence is everything: Your CV and cover letter are your personal marketing documents. Writing strong and professionally reflects confidence in your abilities. Make sure your documents are typo-free, error-free, and presented in a polished way by using a CV template.



What should a CV include?

CV stands for *Curriculum vitae* and usually has a 2 pages length.

It contains the following information:

- 1. Name
- 2. Contact information: email, phone, area of residence (don't provide too much personal information)
- 3. Education: includes a summary of academic background as well as teaching and research experience, publications, presentations, awards, honors, affiliations and other details
- Work experience: past work experience that is relevant to the job in terms of the skills or knowledge required
- 5. Relevant work-related skills



What should a cover letter include?

A cover letter aims to complement your CV by briefly introducing yourself and explaining your interest and fit for the job. It has a length of less than one page and and contains the following structure:

- 1. Name
- 2. Contact information
- 3. Hiring department information (recruiter's name, office address)
- 4. Introduction: tailor it for each job application, it's your opportunity to grab the hiring manager's attention
- 5. Body paragraph: describe your background and achievements. Elaborate on how you will help solve the challenges and mention why you are the right fit to the position
- 6. Closing
- 7. Salutation
